| How does Pioneer Bank protect my personal information? | To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. | Why can't I limit all sharing? | Federal law gives you the right to limit only • sharing for affiliates' everyday business purposes - information about your creditworthiness • affiliates from using your information to market to you • sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. |
| Definitions | |
| Affiliates | Companies related by common ownership or control. They can be financial and non-financial companies. • Our affiliates include a bank holding company, Citizens Bank Group, Inc. and an insurance agency, Pioneer Financial Services, Inc. |
| Nonaffiliates | Companies not related by common ownership or control. They can be financial and non-financial companies. • Pioneer Bank does not share with nonaffiliates so they can market to you. |
| Joint Marketing | A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • Pioneer Bank doesn't jointly market. |
